**CSM students attending colleges outside the U.S.** are assessed tuition as determined by the Office of International Programs. Charges may be guided by agreements with cooperating institutions.

**CSM students on COOP** are not charged tuition and fees.

Graduate students accepted under agreement with **WICHE** are assessed resident tuition.

**Students on active duty** are assessed resident tuition in accordance with State statute.
